<b>Promoter:</b>	Crown Sydney Property Pty Ltd (ABN 12 166 326 861), 1 Barangaroo Avenue, Sydney NSW 2000
<b>Entrants (who can enter?):</b>	<ol style="list-style-type: none"><li>1. New South Wales residents aged eighteen (18) years or over who are dine-in guests at Golden Century, Crown Sydney during the Promotion Period and who are not excluded or prohibited from entering the Promoter's property or any Crown property for any reason.</li><li>2. Entrants who have not been disqualified from any prior promotion, competition or offer for any reason by the Promoter.</li><li>3.
